CREDIT INFORMATION

Notice and Acknowledgement that Credit Information May be Given to a Credit Reporting Agency

I the undersigned do consent and declare and acknowledge as follows:-

Personal information provided to you by me and collected by you from other sources may be disclosed by you to a Credit Reporting Agency and to other persons for loan and investment purposes permitted by the Privacy Act 1988 as amended and by the Privacy Amendment (Private Sector) Act 2000 and in accordance with the Banksia Policy on Privacy and Confidentiality a copy of which is available on request. I acknowledge that Banksia may use my information, on occasion, to inform me about other services or products offered by Banksia and that I may elect to stop receiving such information at any time. I also acknowledge that Banksia may not be able to provide me with the loan products I seek if I do not provide information.

I will promptly advise Banksia about any changes to the credit or personal information held on me. I acknowledge that Banksia relies on me to ensure such information is accurate and complete and that no claim shall be made against Banksia where such information is inaccurate or incomplete as a result of my failure to advise of any change.
